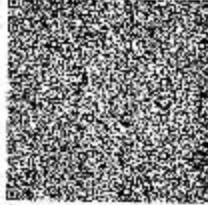

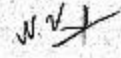

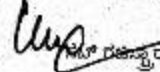

1. The name of the Trust created under this Deed shall be "THE SUNRISE EDUCATIONAL TRUST".

2. The Registered Office of the Trust is located at No.974-A, 2nd Main, 4th Block, Rajajinagar, Bangalore – 560 010.

3. The objects of the Trust shall be as follows:

a) To identify and help meritorious and deserving poor students to pursue their education in recognized institutions.

b) To acquire properties, movable or immovable, by purchases, gifts, donations etc., and to re-sell, lease or otherwise deal with the same in furtherance of the aims of the trust.

c) To collect funds for augmenting the corpus of the Trust, by way of donations, contributions, aids, membership fees or any other source in any manner.

d) To organize public opinion in matters of educational importance and to do such other things as are incidental or conducive to the attainment of the objects of the Trust.

e) To edit, print, publish or/and distribute books, magazines, materials and pamphlets relating to educational subjects;

f) Supply of books, food and clothes, and fees to poor students or grant of monetary assistance to them for such purposes.

g) To grant scholarships, fellowships, medals, prizes, books, stipends, awards to deserving students, scholars' and research workers of all caste and creeds and, generally to do anything incidental or conducive to the above objects or any of them.

4. The Trustees shall bind themselves to manage and Trust in such a manner as may be most beneficial to its growth and shall do every such thing as may be legally necessary for the maintenance and proper functioning of the Trust.

5. For the purpose of the affairs of the Trust and the Institution under the Trust, the Trustees together shall form themselves into a Board of Trustees.

6. **Shri. A. NARASIMHAN**, the Author of the Trust herein shall be the Managing Trustee. He shall guide and supervise the destinies, proceedings and functioning of the Trust. Managing Trustee constituted by the Board of Trustees, shall run and supervise the different activities of the Trust to carry out and implement any of the objects of the Trust under the supervision of Managing Trustee. The Managing Committee shall consist of;

1. **Shri. A.Narasimhan**
2. **Smt. S.Veena Shivakumar**
3. **Shri. N.Vivek**

It has been agreed and decided that Mrs S Veena Shivakumar shall be the Secretary of the Trust till her life time.

7. The Board of Trustees shall have powers to receive subscriptions, donations, gifts, grants from the Government of Public bodies of individuals or organizations and shall have powers to acquire by way of purchase, gifts, grants, demise amalgamation taking over or otherwise, property of every description including movable and immovable for the use and the benefit of the Trust and calculated to promote the aims and objects of the Trust.

8. The Managing Trustee shall be empowered to raise loans or advances repayable with or without interest from Banks or individuals in time of need and also to acquire land to construct buildings for the educational institutions of the Trust. The same shall be ratified in the trustees meeting. The Managing Trustees shall also have the powers to raise funds by organizing benefit shows of any type, exhibitions, fetes, lucky-dip etc.,

9. The Trust and Trustees shall dedicate themselves to advancement of education and shall encourage and organize lectures, debates, discussions and manage literary and cultural activities without any profit motive.

10. The Board of Trustees shall have powers to frame rules for the conduct of business and proceedings connected with the administration of the Trust and also lay down the rules and regulations and frame such bylaws for conducting the business and proceedings of the Managing Committee formed by them from time to time.

11. The Managing Trustee shall have powers whenever he thinks expedient to apply any part of the trust funds in acquiring or purchasing or taking on lease or otherwise any land or building for the development of the trust activities with the approval of the other trustees.

12. The Board of Trustees may at any time whenever felt expedient apply any part of the funds for the publication of books compatible with the educational aims and curricular as well as the cultural values and importance.

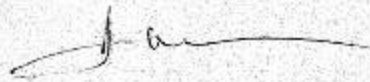

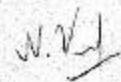
14. Two of the three members shall form the quorum for all purposes.

15. So far as the investment is concerned, the funds of the Trust shall be invested in the modes specified under the Provisions of Section 13(1)(d) r.w.s. 11(5) as amended from time to time. The funds and the income of the Trust shall be solely utilized for the achievement of its objects and no portion of it shall be utilized for payment to the Trustees by way of profit, interest, dividends, etc., However, for carrying out the objects of the Trust effectively, any reasonable remuneration as may be decided by the Board of Trustees may be fixed and paid to any/all the Trustees.

16. The Trustees shall each financial year commencing from 1st April and ending with 31st March of each year cause to be made and prepared all accounts of receipts and expenditure in connection with the objects of the Trust showing separately several heads of receipts and expenditure and such accounts shall be audited by a Chartered Accountant/s in accordance with the provisions of the applicable law as appointed from time to time by the Trustees and the Auditors so appointed shall be paid their remuneration by the Trust.

17. It is declared and understood that the Trustees shall have power to frame rules and/or bye-laws and also alter, vary, amend, delete the rules and/or bye-laws for the conduct and management of the Trust or the Trust Fund for carrying out the objects of the Trust and such rules and/or bye-laws, framed, amended, altered, varied deleted or substituted shall have the same force as if they have been incorporated in the original Trust hereby created but not repugnant to objects of the Trust, provided that no amendment shall be made without the prior approval of the Commissioner of Income tax/Director of Income tax (Exemptions).

18. No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 & 13 and 80 G of the Income tax Act, 1961 as amended from time to time. Further, no amendment shall be made without the prior approval of the Commissioner of Income tax.

19. The Board of Trustees shall fix the remuneration /actual expenses for the Managing Trustee, Secretary and other persons associated with the activities of the Trust from out of the funds. However, payment of remuneration/actual expenses to them shall be reasonable and commensurate with the actual service rendered by each of them for the benefit of the Trust.

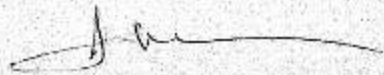
20. The Managing Trustee shall have the powers to sanction all payments of the Trust from the Trust funds. These details will be presented to the Managing Committee in the next Managing Committee meeting for their approval.

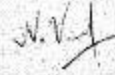

22. The Managing Trustee shall look after the day-to-day administration of the Trust. Any question arising in the administration of the trust shall be decided by the majority of the trustees.

23. The Managing Trustee shall have the powers to negotiate, conclude and effectuate such agreements with the State and Central Government or any other local authorities or bodies of company or companies or individuals for the purpose of outlining financial or technical aid or any rights, privileges or concessions, if any, in any form as they deem fit on such terms and conditions as may appear fit to them or the furtherance of the objects of the Trust.

24. The Board of Trustees and the Trustees individually are to be generally governed by the provisions of the Indian Trust Act.

25. The Board of Trustees shall meet at least once in every three/six months to take stock of the progress achieved and to transact other business pertaining to the activities of the Trust. Full record of the minutes of such meetings shall be maintained by the Managing Trustee.

26. The Board of Trustees shall appoint an Advocate as and when occasion arises and he shall be paid reasonable remuneration for his services.

27. If any vacancy arises in the Board of Trustees, on account of incapacity or persistent neglect of any trustee, the remaining trustees may co-opt any person, provided that a full and detailed reasons for such action is recorded and kept.

Upon dissolution or winding up of the Trust, if there shall remain after the settlement of all its debts and liabilities, any property whatsoever, the same shall not be paid to or distributed among the Trustees or any one else but shall be given to some other Trust or society or charitable institution or association or institutions whose objects are similar to those of this Trust and which enjoys recognition U/s 80G of the Income tax Act, 1961 as amended from time to time.

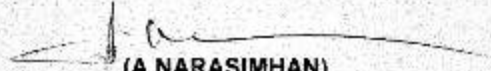

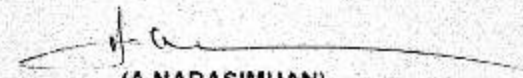

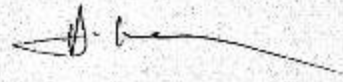
